- 18- The successful bidder shall carry out all the work at the lowest per unit rates inclusive of all taxes offered by any bidder for the same.
- 19-The Chief Executive Officer Shree Ayodhya Jee Teerth Vikas Parishad, Ayodhya will have absolute assigning right to reject the E-tender without any reason.
- 20- All disputes are subject to Ayodhya Jurisdiction.
- 21-If the technical bid of any tender is incomplete, its bid will not be considered.
- 22-If L1 Bidder is not able to complete the work in given time, then tender will be allotted to L2 on the cost of L1.
- 23-Copy of balance sheet ITR of last three consecutive financial year duly certified and audited by Charterd Accountant to be submitted.
